Bishop James King assigned to serve the South Georgia Area

Bishop James R. King, Jr. has been assigned to the South Georgia Area of the United Methodist Church as the new episcopal leader. This announcement came Friday night, July 18 at the Southeastern Jurisdictional Conference in Lake Junaluska, NC.

Bishop King has served the past eight years in the Louisville Area, which includes the Kentucky and Red Bird Missionary Conferences. Bishop King will be the first African-American to serve as the episcopal leader of South Georgia.

“It is extremely important for us to feel like we are where God wants us to be. From the bottom of our hearts and from the depths of our being, we feel like God has been at work preparing us for this moment,” King said to a group of South Georgia United Methodists following the announcement of his assignment.

“We are excited to be where God wants us to be. God has been at work preparing us to come to South Georgia.”

Prior to his election as a bishop in 2000, Bishop King was the senior pastor at Brentwood United Methodist Church in Brentwood, TN. During his tenure in the Tennessee Annual Conference, he also served as a District Superintendent and as the Conference Council Director. He is a graduate of Clark College in Atlanta and received a Master of Divinity at the Interdenominational Theological Center in Atlanta. Bishop King was ordained a deacon in the Central Alabama

Conference in 1970 and an elder in the Central Alabama Conference in 1972. Bishop King and his wife, Rose, have three children.

After serving faithfully in South Georgia for 8 years, Bishop Mike Watson has been assigned to the North Georgia Area. This will be Bishop Watson’s second assignment as an episcopal leader. He was elected at the 2000 Jurisdictional Conference, along with Bishop King.

The election of one bishop, Bishop Paul Leeland, and the re-assignments of others took place at the Southeastern Jurisdictional Conference, which is held every four years at Lake Junaluska, NC. The assignments for the bishops become effective Sept. 1, 2008.

Are We Finished? I Hope Not!

There is an aphorism attributed to Benjamin Franklin that compels our reflection and response if we are to live and fully develop as we are intended. It reads, “When you’re finished changing, you’ve finished.”

To live is
to change.
The world
spins eternally
on its axis.
The seasons
come and go.
Each day is
different from
the last. We

look at family albums, there are both smiles and tinges of regret. We are not what we were; we are not what we will become. To change is to live; to resist change is both futile and misdirected. There is profound wisdom in Franklin’s observation that we are finished when we are finished

changing.

Yesterday, my wife Diane and I were looking at our flowers when she reached down and picked up a beautiful wing feather from a blue jay – one of many that make their homes among our trees and loudly and playfully eat from the seeds our feeders provide. The feather, of course, was a sign of molting among our feathered friends – the process of casting off old, used feathers for new ones. Molting is natural in nature. The only time a bird is not subject to molting is when the bird has died.

Change is constant in growing and healthy churches, too. Not all change may be desirable, but a healthy church is constantly changing to dynamics within and contextual realities without. A healthy church is a relevant church, always seeking to engage its communities in witness and

ministry. Even as a healthy church lovingly and faithfully handles, teaches, and incarnates the eternal truths of our faith, it is also and always a student of its world, constantly changing the ways the church seeks to witness to its world.

We have heard many times that insanity is doing the same old thing again and again and expecting different results.

I long for the day when all of the congregations of our beloved conference will strive diligently to become healthy congregations where change is embraced and new life and relevance are forever being made possible.

Franklin’s maxim – “When you’re finished changing, you’re finished” – is worthy of our attention.

Disaster Response Update

A Disaster Response Update from
Rev. Lowery Brantley:

Mother's Day this year was a horrific day throughout many of our communities and counties as numerous tornadoes touched down. The Governor declared states of emergency in ten counties in South Georgia, from Glynn and McIntosh on the coast to Jenkins, Emanuel, Jefferson, Johnson, Laurens, Twiggs, Bibb, and Crawford. There were also tornadoes in Washington County and in Cobbtown.

South Georgia United Methodists responded by volunteering to help with

the clean up. In Macon/Bibb County, the hardest hit area, Bloomfield UMC and Lizella UMC were centers for early response work, which included debris removal, mucking, and tree removal. Between the two – Bloomfield and Lizella – we did emergency work on over 650 homes. Elsewhere in South Georgia, United Methodists volunteers responded.

Working through the auspices of the United Methodist Committee on Relief, South Georgia United Methodists are a vital part of the long-term recovery work in Macon/Bibb

County. Two UMCOR consultants have come in to help. Barbara Tripp helped with the initial assessment. Rick Hill trained volunteers from Macon/Bibb to do case management. In addition, the Macon District Board of Missions has offered the use of the Aldersgate Church as a central site for case management. The Executive Committee is working with Dr. Brad Brady in regards to the final details of that arrangement.

In addition, two Early Response Team training events have been scheduled for September 13 and October 4 (see details below).

Two Early Response Team Trainings Planned

The South Georgia Conference Disaster Response Team has planned two Early Response Team (ERT) trainings for the Fall. The first is set for **September 13, 2008**, at Tifton First United Methodist Church. The second training is scheduled for **October 4, 2008**, at Pittman Park United Methodist Church in Statesboro. Both trainings will begin at 9:00 a.m. and conclude at 5:00 p.m.

An ERT is a group of 8-12 trained, insured and credentialed people who are deployed into a disaster-site to help

with initial clean-up following a disaster. Teams are deployed after the immediate emergency stage when areas are cleared by government officials and faith-based groups are first welcomed into the area.

Barbara Tripp with the United Methodist Committee on Relief (UMCOR) will lead the trainings. South Georgia Conference ERT identification cards will be issued to participants in attendance. New FEMA and Homeland Security regulations have made it harder in many cases for

volunteers to go into a work site without proper credentials and a photo-ID.

There is a limit of 60 persons per training. Because of the size limitation, participants must pre-register for this event. No walk-ups will be accepted. The cost of the training is \$10.00, which includes lunch and snacks. UMCOR volunteer t-shirts will be available for purchase for \$8.00. Lake Junaluska Dam Restoration Fund

The Lake Junaluska Dam was built in 1912 and is classified as an intermediate sized, Class "C" High Hazard Potential Structure. This means that without proper maintenance, a failure could cause loss of life and significant property damage. Therefore regular inspections are required. The last maintenance project was done in 1977.

Several years ago the State of NC Inspectors determined the dam needed major repairs. In November 2001 SEJAC was faced with regulatory intervention and potential sanctions if a Repair Plan was not submitted. SEJAC hired Pinnacle Engineering to

assess the work and draw plans for permitting. Studies were done and structural engineers determined that the spillway and twenty-six of the thirty-three buttresses needed major renovation.

Repairs and reconstruction of the Dam were done. The construction cost for the entire project was \$3,200,000. Debt service (interest) cost on funds borrowed to complete the project through 12/31/2007 was \$340,000. The outstanding debt on this Dam project as of 6/30/2008 is \$1,960,500.

In 2004, the Southeastern Jurisdictional Conference approved a special asking known as the Lake Junaluska Dam Restoration Fund. The

voluntary fund asks that each local church member pay 50 cents during the 2004-2008 quadrennium. Currently the South Georgia Conference is lagging behind in its contributions. The good news is that there are still a few more months to contribute to this quadrennium's special asking.

The Conference Administrative Services Office would like to encourage your church to make a donation before the end of the year. Donations to the Lake Junaluska Dam Restoration Fund should be made through their office.

***2008 Pathways to a Healthy Church* event will equip lay and clergy**

Equipping churches to become more spiritually healthy will again be the focus for the fourth annual *Pathways to a Healthy Church* event scheduled for Saturday, August 16 at Trinity United Methodist Church in Warner Robins, Georgia.

Forty-three workshops plus three day long workshops have been designed to assist churches struggling in a particular area of disciple-making, and for those who are new leaders to a specific ministry area.

Workshops will help participants be better prepared to guide their congregations in spiritual formation, worship, hospitality, evangelism, social action, outreach, community-building, stewardship, clarity of mission, effective communications, and leadership development. Additional workshops will focus on

ministering to children, youth, young adults and older adults.

Workshop leaders include pastors and laity from throughout the South Georgia Conference who have a proven record in the subject matter they will be presenting.

A Safe Sanctuaries Update from Rev. Lowery Brantley:

By action of the 2007 Annual Conference, every church is mandated to have in place by December 31, 2008, a Safe Sanctuaries policy.

There will be a Certificate of Adoption in the online charge conference forms for both the Administrative Board Chair and the Pastor to sign, certifying that their church has adopted a policy and will be working toward full compliance. A copy of the policy will be given to the District Superintendent. The Certificate of Adoption will be mailed to the Office of Connectional Ministries. The names of these churches will be entered into our church directory database and will be

printed in the 2009 Journal (Church Directory) and in the Master Move List for the Appointive Cabinet.

The 2007 Annual Conference, in adopting a Safe Sanctuaries policy for the Conference, also made the pastor in each local church responsible for seeing that his or her church adopt a local church policy.

All pastors and churches are urged to be faithful to this charge so that we as an annual conference can speak as one voice, offering a safe and secure place for all children, youth, and vulnerable adults.
